Mr. Kandt summarized the facts of the case where Dr. Weingrow's Controlled Substance Registration and Practitioner Dispensing Registration were revoked in July 2018 for dispensing controlled substances and dangerous drugs and allowing controlled substances and dangerous drugs to be dispensed to patients without his handwritten prescription on each prescription. Dr. Weingrow also allowed members of his staff to falsify his signature on prescriptions for medications that had already been dispensed.

Craig Weingrow appeared and was sworn by President Park prior to answering questions or offering testimony.

Jeffrey Setness was present as counsel representing Dr. Weingrow.

Mr. Setness presented information regarding the type of practice Dr. Weingrow intends to open and the list of controlled substance medications Dr. Weingrow intends to prescribe for his patients.

Dr. Weingrow and Mr. Setness answered questions to the Board's satisfaction regarding the status of his registration with the Nevada State Board of Medical Examiners.

Board discussion ensued regarding Dr. Weingrow's practice and potentially placing restrictions on Dr. Weingrow's Controlled Substance Registration.

Mr. Setness explained that imposing restrictions on Dr. Weingrow's registration would make it difficult for him to obtain a job. Mr. Setness requested the Board consider approving Dr. Weingrow's registration without restrictions.

Board discussion ensued regarding the list of controlled substance medications Dr. Weingrow intends to prescribe to patients and to require Dr. Weingrow to report his prescribing history to the Board.

Ms. Long presented to the Board that this proposed regulation expands the role of allowing pharmacy technicians to administer immunizations. This mirrors the responsibility of Medical Assistants. Pharmacy Technicians who wish to assist in immunizations will need to complete additional requirements such as annual training on immunization.

President Park opened Public Comment.

Melissa Shake, RPh Walgreens, expressed support of the proposed language as this would give time for pharmacists to better evaluate patients.

Lauren Paul, CVS Health, expressed support of the proposed language and discussed the CDC guidance on the importance of immunization, especially with a potential vaccine for Covid-19. Ms. Paul stated that allowing pharmacy technicians to immunize would help to lower the burden on health care workers.

Tim Frost, CVS Health, expressed support of the proposed language and he discussed the training for pharmacy technicians in other states who have begun providing immunization.

Dahn Ur, Department of Health, expressed support of the proposed language and stated that allowing pharmacy technicians to immunize is a good step forward.

Liz MacMenamin, RAN, expressed support of the proposed language and stated that there is a need to move this forward quickly as pharmacies will need to plan and prepare.

Mr. Wuest read into the record submitted public comment suggesting that pharmacy technicians should have to complete additional training and complete a CPR training course in order to give vaccinations.

Board discussion ensued regarding the training of pharmacy technicians regarding vaccination as well as pharmacist supervision of pharmacy technicians while they administer vaccinations.

Mr. Wuest reported to the Board that the Crime Lab has seen an increase in Kratom related issues. He explained that the proposed amendment would make both components of Kratom a Schedule I drug.

Mr. Kandt read into the record the written public comment submitted by Laura Knight expressing support of the proposed language.

Mr. Dodge read into the record the written public comment submitted by Join Together Northern Nevada expressing support of the proposed language.

President Park opened Public Comment.

Jamie Ross, PACT Coalition, expressed concern related to community-based issues that revolve around the ease of access to Kratom. Mr. Ross expressed support of the proposed amendment.

Robert Vikre, PACT Coalition, expressed support of the proposed amendment. He explained that in his job as an addiction therapist he has observed many patients turning to Kratom as a way to self-treat opioid dependence.

OPPOSITION TO RESPONDENT'S MOTION FOR CONTINUANCE

Nevada State Board of Pharmacy (Board), by and through counsel prosecuting this matter, Brett Kandt, General Counsel, files this opposition to Respondent Victoria K. Wall, M.D.'s Pre-Hearing Motion for Continuance filed August 24, 2020. This opposition is made pursuant to NRS 622A.360(3) and based upon the following points and authorities and the pleadings on file herein.

MEMORANDUM OF POINTS AND AUTHORITIES

I. FACTUAL AND PROCEDURAL BACKGROUND

The Notice of Intended Action and Accusation (Accusation) was filed and served in this matter together with the Statement to Respondent and Notice of Hearing on or about June 26, 2020. Wall filed her Answer and Notice of Defense on or about July 7, 2020. This matter is set for hearing on September 2, 2020. On August 24, 2020, Wall though her counsel surrender her Nevada controlled substance registration, Certificate of Registration No. CS15026, to the Board (Exhibit A hereto).

II. LEGAL STANDARD

NRS 622A.360(2)(a) provides that a party may file a written motion to request a continuance. NRS 639.247(2) provides that a continuance may be granted "for cause shown." Courts have deemed "good cause" to mean "a substantial reason; one that affords a legal excuse." Price v. State, 409 P.3d 889 (Nev. 2017) (citations omitted).

III. ARGUMENT

Wall's voluntary surrender of Certificate of Registration No. CS15026, together with her responses and judicial admissions and her execution of a DEA Form 104 surrendering her DEA Certificate of Registration No. BW8998025 to the U.S. Drug Enforcement Administration for Cause on June 14, 2020, demonstrate that there is no good cause for a continuance.¹

NRS 233B.121(6) provides "The voluntary surrender of a license in a contested case shall be deemed to constitute disciplinary action against the licensee." "[W]hen used in a statute, the word "shall" imposes a duty on a party to act and prohibits judicial discretion and, consequently, mandates the result set forth by the statute." *Goudge v. State*, 128 Nev. 548, 553, 287 P.3d 301, 304 (2012). NRS 233B.121(6) was enacted to prevent licensees facing disciplinary action from voluntarily surrendering their licensees to avoid responsibility for their conduct.

Respondent's Pre-Hearing Motion for Continuance should be denied and the September 2nd hearing proceed to permit the Board to make a formal record of Wall's voluntary surrender of her Nevada controlled substance registration and to issue a final decision imposing disciplinary action on that basis. *See* NRS 233B.125; NRS 622A.380(1)(l)(2); NRS 639.251. Thereafter, that discipline will be reported to the National Practitioner Data Bank pursuant to 42 U.S.C. § 1396r–2 and 45 CFR Part 60.

¹ Federal law requires that every practitioner who dispenses any controlled substances obtain a DEA registration. 21 U.S.C. § 822(a)(2). 21 U.S.C. § 823(f) requires that a practitioner be authorized to dispense controlled substances under the laws of the State in which he or she practices in order to obtain a DEA registration. *See also Hooper v. Holder*, 481 F. App'x 826 (4th Cir. 2012). Practitioners must be registered with the Nevada State Board of Pharmacy pursuant to NRS 453.226(1) to dispense any controlled substance within this State. 21 CFR § 1306.03 requires dual registration to issue a prescription.

IV. CONCLUSION

For the foregoing reasons, the prosecution respectfully requests that the Board deny Respondent's Pre-Hearing Motion for Continuance, admit Wall's voluntary surrender of Certificate of Registration No. CS15026 into the record as evidence, and proceed to judgment as a matter of law. To whom it may concern:

My name is Jevons Wang and my case number is 20-008-PT-S. I am writing to request a rehearing/appeal for the determination made on my case during the July 15th, 2020 at the Nevada Board of Pharmacy meeting. I apologize for the common language. Due to the fact that I am unable to afford representation, I will be representing myself in all matters. Before I discuss the issues within the determination I received, I want to be clear that I do not wish to have my license reinstated. I merely want to request that the Board not consider this a disciplinary action.

First, I would like to say that I have made some mistakes regarding how I personally handled this situation. To start from the beginning, I appeared before the Board as a new resident of Nevada with an Oregon pharmacy technician license and national PTCB certification. I wanted to obtain my pharmacy technician license to get a job in Nevada, so I agreed at the January 2019 meeting to enroll in the PRN-PRN program. I initially attended the program regularly and was willing to participate in the program. As time went on and only being able to find work as a temporary pharmacy technician for around 2 months, I decided to go back to school. In August of 2019, I informed Larry Esposito at the PRN-PRN program that I would need to adjust my schedule with him because of my classes. We both agreed and I continued with the program. It was around November or December of 2019 that I went to Larry again and told him that I did not want to complete the program. I told him that I wasn't working as a pharmacy technician and I was not interested in finding a job as a pharmacy technician anymore. I was also going to school, so I could not afford to participate in the program as it cost around \$200 per month. In all honesty, I was having a hard time paying for the program since September 2019, but Larry was kind and let me continue. That is my side of the story to the current events unfolding in my case with the Board. I did not keep in contact with Larry after that, which was a mistake that I had made. To add, I was able to fulfill all requirements of the PRN-PRN program while I was in attendance (no positive drug tests).

To address my shortcomings regarding my case, I'm not sure why I didn't contact the Board directly. I guess I didn't think it was going to be categorized as a disciplinary action on my license. I don't know much about what I should have done legally. But in all honesty, I assumed that if I dropped out of the program, my license would just be revoked. I didn't realize that it would count as a disciplinary action or else I would have taken care of this matter differently. I only worked one job while holding my Nevada pharmacy technician license and I worked at ACRX Specialty Pharmacy with no complaints from customers or my employer. The job was just a couple months long and then I decided to not pursue this pharmacy technicians license anymore. I urge you to consider all aspects of my case. Thank you.

Lastly, I would like to address the errors in the notice I received from the Nevada Board of Pharmacy. Whether or not the Board decides to rehear my case, I need to correct a few things in the notice. The first item I would like to correct in the notice is my failure to appear at the meeting. I was notified by phone only that the Spring 2020 meeting was cancelled, and I was told a new date would be given to me when it was finalized. I did not receive any further

communication. I understand that there was certified mail sent to me, but I did not receive it, nor did I receive a phone call like when the Spring 2020 meeting was cancelled. If I had known of the new meeting time in July, I would have been able to notify the Board that I have medical conditions that put me at high risk for severe complications if I contract COVID-19. If the Board would like a physician's note, I am able to provide one. I also want to point out that the notice states the meeting was March 18, 2020. It was not, because that meeting time was cancelled. The first paragraph of the notice also states that I failed to appear at some meeting on April 15, 2019, which is also incorrect. I was in attendance at the meeting where this matter was brought up in 2019 and there was no other meeting that year that I was requested to appear at.
