Mr. Kandt provided background information on the outcome of the Cannabis Equity and Inclusion Community vs. Nevada State Board of Pharmacy lawsuit and requested the Board provide Board Staff with direction moving forward.

The Board discussed the outcome of the case and potential options moving forward.

After discussion, the Board agreed that filing an appeal and moving for a stay of the Court's Order would be in the best interest of the public's safety and welfare.
