Dear Madison Paskett:

The following information is a personal narrative as to what happened at the time of incident's in regards to APRN application for Lonny Krause.

On October 14, 2013, myself, Lonny Krause, along with multiple others, around 10-14, were at an acquaintance's house. It was visible that there was alcohol in the house, with no one over the age of 21 at the time. No alcohol was ingested by Lonny Krause. That night, police showed up and gave unlawful for minor to possess an alcoholic product to all individuals, whether they were drinking or not because no one was over the age of 21. No blood alcohol level test was performed or breathalyzer was preformed. The case went to the Wayne County Justice Court system on September 24, 2014. Lonny Krause plea not guilty and the case was dismissed on September 24, 2014.

On February 16, 2014, myself, Lonny Krause, along with two others were driving in a car. One passenger was 26 years old and the other 18. Police officer D. Brinkerhoff pulled the car over and explained that the 12 pack of beer was against the law to have in the car to the 26 year old, because the underage was not family. No alcohol was open, no alcohol was ingested. Officer cited myself, Lonny Krause, along with another underage individual with Possess by minor measurable amounts. Lonny Krause plea not guilty to offense on February 02, 2015, and the case was dismissed on February 02, 2015.

On January 24, 2010, myself, Lonny Krause was riding a snowmobile with an expired registration. I was pulled over, and given a citation for operated or transporting w/o current registration. The fees were paid and all actions taken care of in timely appropriate manor. Case dismissed on February 03, 2010.

On August 09, 2015, I was arrested with Impaired Driving. That night I was consuming alcohol, later to find out that one of my friends had not been heard from after driving home in a non-cellular reception spot. I went to look for my friend, to find him needing medical help, crashed in a canyon. I activated the 9-11 response. When they arrived they asked if I was drinking, which I honestly told them. They arrested me. On May 31, 2016 the case was dismissed.

It seems that most of these cases I was at the wrong place at the wrong time. I have learned as getting older and getting more education that it is important to know who you are with and what is going on. Simple decisions can affect you as a professional. It has now been + years since any issues with the law. I follow my nursing standards and will continue to do so.



Dear Sir or Madam.

I want to convey the circumstances behind my conviction for wet and reckless driving in violation of VC23103 in case No. 19M1022316 (see attached court documents). In addition, as a result of this conviction the California Board of Registered Nursing has filed an accusation (the hearing is pending and is set for March 23, 2020). The board administrative action/accusation is not considered at all practice related and therefore my California RN license and FNP license remains, active, valid, and unrestricted.

The wet and reckless driving event occurred on November 2018 shortly after I graduated from University of California San Francisco (UCSF) with my Doctor of Philosophy Degree (PhD) in Nursing (see attached CV).

Please know that two years before my arrest, I became a father, and my son was delivered prematurely at 27 weeks weighing 2lbs 9oz in Toronto, Canada. Unfortunately, my wife went into emergent labor 3 months early and my son remained in a neo-natal intensive care unit for approximately 3 months while we were visiting. Although we lived and continue to live in the Sacramento area, we had to spend the first months of my son's life in Toronto.

As a new father I decided to optimize my health and well-being—with a desire to be able to spend as many healthy and happy years with my son. Thus, I started to engage more regular physical activity and a healthier diet, and I made a personal decision to limit alcohol during this time. I shared these goals, my motivations, and aspirations with my wife, sister, mother and other family members and friends who welcomed my new focus on my health.

This focus brought profound benefits to all aspects of my life. I subsequently lost over 50 pounds, and I was able to successfully finish my PhD (see character reference letters) from UCSF and was promoted to Co-Director of our nursing program on our Sacramento campus—in partnership with the VA Northern California Health Care System (see additional character reference letters attached and CV).

The event that occurred that serves as foundation for this letter happened on November 1, 2018. I had not had any alcohol in a long time (birth of new son description above and note I had also lost a significant amount of weight—described above). That night I was out celebrating my new accomplishments—my PhD, new Co-Director role at the University of San Francisco, and all that I had worked for in the past 20 years let along the past few years--after work. I had consumed 2 beers with colleagues and friends. Clearly, I made a mistake in in judgement when I got behind the wheel after this short celebration. While I was driving, I decided to stop driving, and I exited the freeway and approximately ¼ mile after exiting the freeway--pulled off the road and fell asleep in my car.

When the officers arrived (they said that someone had called about a car that they assumed had mechanical problems)—I was extremely cooperative, and I submitted to a blood test and later it was determined I had a blood alcohol level of .09 and the charge was subsequently a wet and reckless violation.

This event is not reflective of all I have accomplished and worked for the past 20 years--including my paramount and demonstrated commitment to the nursing profession and to serve those with the greatest need (see attached CV) and my last 14 years as a registered nurse serving those with the greatest need--with a completely free of any events affecting my RN licenses.

I realize my actions were very wrong and I am not going to make any justifications. I have complied with my legal responsibilities to include completion of a 3-month first offender program, and court fine payments. I have now have completed the education and counseling required as a result of this violation (see attached Notice of Completion Certificate-Breining Institute). I have found the education insightful because it has-among many other things- provided insights into the pathophysiology of the health effects of alcohol consumption and the pathophysiology of all forms of substance abuse. This is important to me personally because of my focus on my own health and wellbeing and for me professionally to help others. Also, the counseling is important to me-as it helps me recognize the situation as it is and provides a realistic perspective because the stress of this violation is difficult-an it helps me help others. I also recently attended a MADD Victim Impact Panel (see attached proof of completion) that I also found insightful as it helps me better understanding the potential impact of the situation and potential consequences—and to help me serve others. In addition, I have completed 26 CEUs relative to management and treatment of related substance abuse CEUs to better my commitment to help others and myself understand this phenomenon. The certificates of completion and brief descriptions of the three courses are attached.

These actions along with a daily focus on my health and wellbeing reflect my personal choices to negate this event from ever occurring again. By personal choice, I have not had any alcohol since my arrest. I recognize that I made a mistake, this is the only mistake I have made of this nature in my 14 years as registered nurse and I am sincerely remorseful for this action. I have also attended counseling to better myself and acupuncture, massage, and meditation to best deal with stress and focus on my health. In addition, I have recently completed a profoundly useful Zen Leadership intensive training to stay grounded in this moment and all moments of stress that happen inevitably in life. All these actions have been extremely helpful to me as I process this difficult time and stay focused on continuing to be a strong and effective leader, father, and Registered Nurse.

I hope the Nevada Board of Pharmacy will consider my contributions to the nursing profession and the foundations I have put in place to ensure no such actions occur in the future. I hope that the board will consider my letters of character reference from those who supervise me in direct patient care and leadership roles and who have guided and directed me as a registered nurse (RN), a nurse practitioner (NP), and a doctoral prepared nurse (PhD) as I have served the underserved locally and throughout the world in my work.

Finally, a short summary of events that occurred long before I ever became a registered nurse or nurse practitioner in any state. These events occurred 16 and 17 years ago respectively:

Maricopa County, AZ—September 4, 2003—Case#: 20032080189—Court: North Mesa Maricopa County Court—Explanation/Short Summary of Events:

- Was in going through a very difficult break-up with my girlfriend at the time and had decided to sleep in my car instead of driving—after consuming alcohol.
  - O I recently have attempted to have this case "set aside" due to the event happened long ago, currently after having contacted and paid an attorney this is the response and the only documentation for this event available at this time.

### Research

My PhD research focuses on serving the populations of the world that combined--are often referred to the "bottom billion". The populations that make up this "bottom billion" are often the most marginalized, underserved populations concentrated in Asia, South America, and Africa. In advancing my commitment serving those with the greatest need, the nursing profession and the international community—my specific area of interest for research began in 2006-2007 when I had the opportunity to work with the United Nations Higher Commission of Refugees in Addis Ababa, Ethiopia. Working with medical faculty from Penn State University and local implementing partners we received funding to conduct the preliminary foundations for a study to evaluate the role of survey-based methods and exposure monitoring to carbon monoxide as health assessment tools for women (and children) exposed to smoke from biomass cooking fuels.

In Ethiopia in 2007 with local implementing partners the team successfully carried out the implementation of the preliminary efforts. As part of my continued commitment to nursing education and to improving the lives of the underserved I took this opportunity to teach local refugee student nurses to become community health workers focusing on primary and urgent care, obstetrics, and pediatrics. I helped develop partnerships with local colleges and NGOs to teach these refugee nurses, and these nurses went on to serve in their own severely underserved refugee community.

Based on this experience and my continued exploratory research I recently published with co-authors an article in the Journal of Community Health Nursing (November, 2012). This manuscript serves to increase nurses' awareness of the impact of household air pollution from cooking fires on women and children's health outcomes. The article promotes the need for nurses to act in key roles to develop and support research that focuses on this global healthcare priority, which was the 4<sup>th</sup> (now the 7<sup>th</sup>) largest health risk factor contributing to disease and death in the world. This dedication to improve the lives of diverse underserved populations is what motivated me to further my education to become a nurse, a nursing professor, and Advanced Practice Registered Nurse, and now a doctoral-prepared nurse. Early in my pursuit of higher education I was honored to become a Friend of Nursing Scholar, and to receive an Academic Excellence Award along with induction into Sigma Theta Tau International Honor Society of Nursing from the University of Colorado – Anschutz Medical Campus. I was also honored to be chosen as the honorary speaker to represent my graduating class for the Master's of Nursing Program, University of Colorado – Anschutz Medical Campus May 2010 Commencement Ceremony. I am honored to have received the UCSF Graduate Dean's Health Sciences Fellowship in both 2012-2013 and 2014-2015.

### Service

I have a passion to serve in demanding underserved populations. As a United States Peace Corps Volunteer in Hungary, I found this to be one of the most rewarding times in my life. From one visit I was speaking Spanish to an expecting teenage mother and in the next visit helping a young homeless gentleman living in his car with his mentally challenged wife. Now local in San Francisco, I participated actively to address diversity and retention issues within the UCSF nursing program and work with local underserved to improve access to health care, and generally on a daily basis work to improve the lives of the underserved.

I believe beyond my day to day commitment as a Co-Director and Faculty, I am also pleased to have

To Whom It May Concern:

I, Mark F. Towns M.D FASM, am a physician who is licensed in the state of California (Med License # A100676). I actively practice Addiction Medicine and Internal medicine and I am board certified in both specialties. For over 10 years, I have devoted more than 75% of my working time to my practice of Addiction Medicine and Internal Medicine. I have been the CEO and Program Director for Towns Health Services Inc. (THS), for over 10 years as well. I am an Addiction Fellow in the American Society of Addiction Medicine (FASM).

In my role as administrator for THS, I deal with employee behavioral issues regularly. I am in charge of the THS Credentialing, Peer Review, Quality Review, and Utilization committees. I am also the Medical Review Officer for drug testing at all of the THS facilities and Hayes Chiropractic Services.

I have been asked to evaluate Jason Thomas Speaks, and to conduct a full independent addiction consultation and assessment of him to assess him for dependence on drugs or alcohol that might reasonably affect the safe practice of nursing or nurse practitioner.

I hold a valid unrestricted California medical license, which includes scope of practice to conduct a clinical diagnostic evaluation. I have at least 3 years of experience in providing addiction evaluations of health professionals with substance abuse disorders or issues, and, I have been approved by the Board of Registered Nursing to conduct my examinations and evaluations of healthcare professionals which will include Jason Thomas Speaks, who is a registered nurse and certified nurse practitioner.

I have received a copy of and have reviewed the Accusation Against Jason Thomas Speaks Case No 2020-163, thoroughly.

Jason Thomas Speaks was thoroughly examined by me 11/04/2019. The goal of this examination was also to determine if Mr. Speaks is able to practice safely as a nurse and or nurse practitioner. His evaluation included a Substance Abuse Assessment, which included a complete Physical Health Examination, and Mental Health Examination.

#### Jason Thomas Speaks Registered Nurse License Number 824970, Nurse Practitioner Certificate No. 22258

This is a 49-year-old male with a medical history of pulmonary embolism, Factor V Leiden, and GAD, who presented for a comprehensive addiction evaluation. He received his Registered Nursing License on July 20, 2012. On or about august 16, 2012, the California Board of Registered Nursing issued his Nurse Practitioner certificate.



At the beginning of the interview a CURES report was pulled and it was negative.

He did not smell of alcohol and his 12-panel urine drug test was negative. His alcohol breathalyzer test was negative. Confirmatory testing was sent and the results were negative. He received a copy of the definition of a standard drink prior to the interview and the definitions were discussed with him.

We also reviewed the job description for a nurse and nurse practitioner with him which included:

#### **Nurse Job Description:**

- Identifies patient care requirements by establishing personal rapport with potential and actual patients and other persons in a position to understand care requirements.
- •Formulates a nursing diagnosis through observation of the patient's physical condition and behavior, and thorough interpretation of information obtained from the patient and others, including the health team.
- •Formulates a care plan, and collaboration with the patient, which ensures that direct and indirect nursing care services provided for the patient safety, comfort, hygiene, and protection, and for disease prevention and restorative measures.
- •Performs skills essential to the kind of nursing action to be taking, explains the health treatment to the patient and family and teachers the client and family how to care for the patient health needs.
- •Delegates tasks to subordinates based on the legal scope of practice of the subordinates and on the preparation and capability needed in the test to be delegated, and affectively supervises nursing care being given by subordinates.
- •Evaluates the effectiveness of the care plan through observation of the patient's physical condition and behavior, signs and symptoms of illness, and reactions to treatment and through communication with the client in health team members, and modifies the plans as needed.
- Acts as the patient's advocate, as circumstances require, by initiating action to improve healthcare or to change decisions or activities which are against interest or wishes of the client, and by giving the client the opportunity to make informed decisions about healthcare before it is provided.

- •Establishes a compassionate environment by providing emotional, psychological, and spiritual support to patients, friends, and families.
- •Promotes the patient's independence by establishing patient care goals; teaching patient, friends, and family to understand condition, medications, and self-care skills; answering questions.
- Assuring quality of care by adhering to therapeutic standards; measuring health outcomes against patient care goals and standards; making or recommending necessary adjustments; following hospital and nursing division's philosophies and standards of care set by state board of nursing, state nurse practice act, and other governing agency regulations.
- Resolving patient problems and needs by utilizing multidisciplinary team strategies.
- Maintaining safe and clean working environment by complying with procedures, rules, and regulations; calling for assistance from health care support personnel.
- •Protecting patients and employees by adhering to infection-control policies and protocols, medication administration and storage procedures, and controlled substance regulations.

## **Nurse Practitioner Job Description:**

According to the American Association of Nurse Practitioners (AANP), nurse practitioners provide high-quality primary, acute, and specialty care health services across the lifespan and in diverse settings. Although an NP's job description would differ slightly based on the population they serve and the setting in which they work, all NPs have a number of things in common:

- NPs are licensed, independent practitioners that practice in ambulatory, acute, and long-term care settings as primary and/or specialty care providers.
- NPs may work autonomously or in coordination with other healthcare professionals.
- All NPs possess advanced clinical training and competency to provide care beyond the scope of registered nurses.
- All NPs possess a graduate education, possessing a Master of Science in Nursing (MSN) or higher.
- NPs diagnose, treat, and manage acute and chronic illnesses.

He had his had his first drink at the age of 16 years old. He has no PMH of drug use. He has no cravings for alcohol or history of violent or sociopathic behavior.

In high school he drank 1 time per month perhaps 3 beers on occasion. Thereafter, after high school, while in college, he would drink roughly 1 time per week drinking 3-4 beers per sitting.

He received a DUI, at the age of 31 years old, on 04/22/2002. He had been out drinking with friends and had driven home after dinking.

Then, at the age of 33 years old, he received another DUI September 2003. He had been in an unhealthy relationship and had driven after drinking heavily secondary to that bad relationship.

After this, he would only drink 1-3 beers one time per 1-2 months. This drinking pattern continued until he became 47 years of age in 2017 when he had his son. He stopped drinking altogether because he wanted to be a good role model for him.

Then, on or around November 1 2018, after successfully obtaining his PhD from UCSF, his dean visited his school and Mr. Speaks went out to celebrate his accomplishment and he had 3 beers. He was driving home and he was tired so he pulled over off of the road and was sleeping in his vehicle. The police arrived to check on him and he was found to have a blood alcohol level of 0.9. He was subsequently convicted of a wet and reckless violation. He subsequently completed DUI education and counseling courses. He has quit drinking altogether since that incident.

He recently received an Accusation from the Board of Registered Nursing.

He has no family history of alcoholism or substance abuse. He has never done any illicit drugs. He denies having any cravings for alcohol. He has had no depressed mood or suicidal or homicidal ideation or psychiatric problems.

His story is consistent with the events outlined in the Accusation Case No. 2020-163. He has been charged with violation of Business and Professions Code (Code) 2761 (a and f) and 2762 (b and c). He is also subject to Code 490 (a, b, c, and d) and 125.3.

The Accusation also made note of the following important information: Causes for Discipline:

- -Conviction of a crime
- -Dangerous Use of Alcohol
- -Conviction regarding the Consumption of Alcohol
- -Matters in Aggravation (on April 14, 2014) Code 498 secured license by fraud, deceit, or knowing misrepresentation of a material fact. In addition, violation of Business and Professions code 2761 (e) making or giving false statements or information in connection with the application for the issuance of a certification or license.

#### Methods:

His CURES report was obtained upon arrival.

His CURES report was reviewed, and, it was negative. He did not smell of alcohol and his 12- panel urine drug screen and alcohol saliva test were negative. Confirmatory testing was sent and it was negative. He did not appear to be intoxicated or under the influence of drugs.

Scoring for the Simple Screening Instrument for Substance Abuse was administered to the patient and his total score was 1 which confers minimal to no risk for substance use disorder.

Psychiatric screening including a full mental status exam and Psychiatric Assessment Form with Folstein's Mini-Mental Status exam were performed, and both were unremarkable. Psychiatric Addiction Screening Questions were unremarkable. The State of California health questionnaire was completed and reviewed and he had a full history and physical. They were unremarkable.

Alcoholism risk factors were assessed using the Adverse Childhood Experiences (ACE). His score was 0. T-ACE Screening tool was unremarkable with a score of 0. Being a male confers a 17% lifetime chance of meeting criteria for alcohol dependence. The DSMV Alcohol Use Disorder Criteria Checklist was negative.

#### Corroboration:

Consent for release of confidential information to contact three persons was obtained:

I called **Mrs. Krista Speaks**, his sister, on **11/10/19**. She answered all of the addiction consultation phone interview questions with no concerns. She reported that Mr. Speaks was a very kind, considerate, and good person. He thinks of others and loves his work. He is compassionate with others. She has no concerns about him.

I then contacted his aunt, Mrs. Nancy Melander, on 11/13/19. She answered all of the extensive addiction consultation phone interview questions with no concerns. She thinks that Mr. Speaks is a great guy. She has spent a lot of time with him at various social gatherings and she has never seen him intoxicated. He does not drink much at all. He is on a big health kick right now.

I called **Mr. Ryan Melander,** Mr. Speak's cousin, on 11/14/19. He, too answered all of the addiction consultation phone interview questions with no concerns. He is impressed with Mr. Speaks. He feels that Mr. Speaks can stop drinking at will and has had no history of violent or sociopathic behavior. He has made positive life changes by investing in his health.

# Review of Reference Letters of Support:

I reviewed the impressive letter from Mario R. Frias MSN, RN, CNL written on May 6, 2019. He has worked with Mr. Speaks over the past 3 years. He reports that Mr. Speaks has owned his mistakes and is a diligent, organized, trustworthy, and responsible person. He is not a threat to the public and he has

not shown any erratic, impulsive behavior, or poor or unsafe judgement. He is an invaluable asset to the nursing community.

I also reviewed the excellent letter of support from Carol-Dawson-Rose, RN, MS, PhD, and FAAN from the UCSF School of Nursing, written on 5/10/2019. She has known Mr. Speaks for the past 5 years. She reported that Mr. Speaks has never demonstrated any actions or behaviors consistent with alcohol use or abuse. He has always demonstrated the highest levels of ethical and professional behavior.

#### Methods:

Examination Methods: Review of the Accusation Against Jason Thomas Speaks Case No 2020-163, and the Statement to the Respondent thoroughly.

In addition, his CURES search Summary and 12-panel POC Urine drug testing, (which was sent for confirmatory testing) were both appropriate.

Comprehensive confirmatory testing was also appropriate. His alcohol breathalyzer test was negative. For the interview and historical information; information was gathered from the patient, Physical examination and History; Psychiatric Assessment Form; Brief psychiatric rating scale; Folstein's MMSE, THS simple screening instrument for substance abuse self-administered: CRAFT/adverse childhood experience (ACE) risk factors for alcoholism and/or substance abuse questionnaire were administered. The State of California Health questionnaire; DSM V alcohol Use Disorder Checklist: and corroborative phone calls were also used. To assess the current mental health status of Accusation Against Jason Thomas Speaks Case No 2020-163, and the Statement to the Respondent thoroughly.

We have conducted: a psychiatric evaluation which includes screening questions, brief psychiatric rating scale, and simple screening instruments along with a complete Mental Status Exam, and physical exam, as well as corroborative efforts.

We have reviewed the job description for a nurse and nurse practitioner See above.

#### **Summary and Recommendations:**

After my full psychiatric, mental, and physical examination of **Mr. Speaks**, and subsequent thorough review of the information obtained in the examination methods, along with extensive corroborative efforts, substance use disorder, based on **DSM V criteria for Alcohol Use Disorder**, **Substance Use disorders have been ruled out.** Corroborative efforts verified that he has had no not met the criteria for Alcohol Use Disorder. He In addition, has had no social problems except for DUI in college on 04/22/2002, another DUI related to a bad relationship on September 4 2003. After a period of over 15 years, in November of 2018, after celebrating his accomplishment of getting a PhD, he received a Wet Reckless with a BAL of 0.9. He has no objective evidence of alcohol use disorder after thorough evaluation and corroboration.

He is at low risk for the development of alcohol use disorder and does not satisfy the DSMV criteria for Alcohol Abuse Disorder.

In addition, based on my complete evaluation, he is mentally stable and he has no history of violent or sociopathic behavior.

#### Recommendations:

I recommend that he thoroughly review the pamphlet "Rethinking your drinking," published by the National Institute of Health. It thoroughly explains the limits on alcohol intake for males and at risk drinking limits. In addition, he is to not drink alcohol and drive under any circumstances. He can get and Uber or have a sober 3<sup>rd</sup> party drive for him, if he plans to drink at a party, or other celebratory occasion in the future. His prognosis is good and I will not be prescribing any medications for him. He is definitely capable of safely performing the functions of a registered nurse and nurse practitioner in a safe and competent manner and has been doing so.

- 6. The patient's prognosis is good.
- 7. My opinion is that **Jason Speaks**, based on my extensive evaluation, can perform the functions of a registered nurse in a safe and competent manner.
