I am requesting the approval to conduct Medication Therapy Managment services via phone with participants from my mobile phone number ( at my home address, and also from the Roseman University of Health Sciences SHIP call center lab on campus. The calls and documentation will follow my previously approved application approved from the December 5, 2019 NV State Board of Pharmacy meeting.

4. A brief statement detailing how the declared emergency caused the need for the waiver.

This waiver will allow me to continue working with patients diagnosed with Diabetes, High Blood Pressure and High Cholesterol to have medication reviews with a licensed pharmacists as part of the CDC 1815 and 1817 grant program. Currently Dignity Health and Wellness Center's are not open to the public or non-employee access. Therefore the MTM services are not accessible to Healthy Heart participants, Diabetes Prevention Program participants and others qualifying for the program assistance.

5. Relevant laws that the licensee is requesting are waived.

The relevant law being waived is NAC 639.403 - Application required for pharmacist to engage in practice of pharmacy at site other than licensed pharmacy; exemption for pharmacists who administer immunizations. (NRS 639.070). In this application the use of off-site calls from mobile number and the Roseman SHIP call center were not included and are being requested as alternate options to conduct approved MTM work by the Board (see attached application).
