## 2025 Nevada Marketing Code of Conduct Report on Compliant Companies

Pursuant to NRS 639.570

Published  
1-15-2026

## **Background Information**

Nevada's Marketing Code of Conduct statutes were created by the 2007 Nevada Legislature under [Assembly Bill 128](#) (AB128), which was codified into the Statutes of Nevada as [NRS 639.570](#). The Nevada State Board of Pharmacy adopted regulations pursuant to NRS 639.570(4) in 2008. Those regulations are detailed in NAC 639.6053-6057, NAC 639.616-619, and NAC 639.69573-69577. For many years, the [Nevada State Board of Pharmacy](#) (Board) referred to the annual filing requirement as AB128. However, because AB128 has been codified we are now using the phrase "Marketing Code of Conduct" (MCC), or "Annual Marketing Code of Conduct".

[NRS 639.570](#) requires a wholesaler or manufacturer who employs a person to sell or market a drug, medicine, chemical, device or appliance in Nevada to submit annually to the Board certain information regarding their marketing code of conduct. It also requires the Board to prepare and submit to the Governor, and Director of the Legislative Counsel Bureau for transmittal to the Legislature, a compilation of the information submitted. Any information submitted that is identified as a trade secret is not included in the report prepared for the Governor and the Director of the Legislative Counsel Bureau.

The filing period is May 1<sup>st</sup> – June 1<sup>st</sup> annually, for the preceding 12-month period ending on April 30<sup>th</sup> of the same year. The Board publishes a list of companies that submit a compliant filing pursuant to [NRS 639.570](#) to its [website](#) annually. The [website](#) also houses information regarding Nevada's Marketing Code of Conduct, including the [annual filing form](#).

In 2022 the Board revised the annual filing form to include the Board issued license number of the company named in the filing. Additionally, the annual filing form was streamlined, with an effort to make completion of the form easier and more concise. A few changes were made to the annual filing form in 2023. Minor changes were made to the annual filing form for 2024 to clarify requirements in sections five and nine. The 2024 form will continue to be used in 2026 without any revisions to reporting requirements, however, the email address for submitting the annual filing has been updated. The Annual Marketing Code of Conduct filing form is available on the Board's [website](#).

The tables that follow include data on each company that provided a compliant Annual Marketing Code of Conduct filing during the 2025 filing period. Some exceptions to the deadline were granted, and every effort was made to be accurate, as well as comprehensive, in our collection and processing of data.

The 2025 compliance report includes all entities that provided a compliant filing pursuant to [NRS 639.570](#), regardless of their license status to conduct marketing, sales, or distributive functions of federally restricted (Rx Only) drugs and devices in Nevada. Three distinct tables are utilized to categorize compliant filings based on license status. Table 1: Companies that have an active license issued by our Board, a license that was recently closed or not renewed, or a license is not required; Table 2: Companies that have a pending license application with the Board; Table 3: Companies that are neither licensed by our Board, nor have they submitted a license application as of the time of drafting this report. Also included in Table 3 are companies that applied for a wholesaler license in the past but did not complete the application process before their application expired pursuant to [NRS 639.127](#). Companies listed in Tables 2 and 3 were reviewed for license status in December 2025, whereas companies in Table 1 either had an active license issued by the Board when their annual filing was reviewed, or they completed the license application process prior to drafting of this report. Additionally, some companies listed in Table 1 have the words “closed”, “non-renewed”, or some other information displayed with the license number, indicating updated information as to their license status at the time of drafting of this report.

Companies listed in Table 3 may or may not be marketing Federally restricted drugs or devices. By listing a company in Table 3 the Board is not making any statement, or determination that the company is performing activities that would require a license pursuant to [NRS 639.233](#), Nevada’s License Required statute.

While every effort has been made to ensure the accuracy of data provided in the following tables, the data should not be relied upon to determine current license status for any named entity. Additionally, other data tabulated, such as license number and address should be independently verified before use. Our [license verification tool](#) is available at the Board’s website.

## **Data Compiled from the 2025 Marketing Code of Conduct Filings**

The Board received 676 compliant Marketing Code of Conduct filings for 2025. Of those filings, 623 were from Board licensed entities, or entities that applied for and successfully obtained a license from our Board prior to the publication of this report. There are 6 companies included in this report that have a pending license application with our Board, 53 filings from companies Not Licensed by our Board, while 61 of the filings are from companies that provided their first filing.

The Board received a small number of Marketing Code of Conduct filings that did not comply with the filing requirements. Companies that filed Marketing Code of Conduct documents that were determined to be non-compliant received email, and in some cases telephonic communication requesting corrections or additional information. In some instances, a company simply used an obsolete filing form. In other instances, the documents were incomplete or lacked content, and therefore it was determined they did not meet the regulatory requirements. Most instances of non-compliant filings were resolved in a timely manner and were subsequently included in this report. Only two companies did not re-submit their MCC with the necessary corrections that would have placed their Marketing Code of Conduct filing in the compliant group, with subsequent inclusion on the tables that follow. Both companies whose filing was determined to be non-compliant hold an active Nevada wholesaler license.

## **License Types Represented in the 2025 Annual Marketing Code of Conduct Filings**

### **WH - Wholesaler or Warehouse**

This is the most represented license type in the MCC filings. It includes companies that are traditional wholesalers, and non-resident manufacturers including manufacturers that use a 3PL to distribute their Rx only drug(s) and device(s). Of note, drug and device manufacturers that utilize a 3PL under the title model<sup>1</sup> but hire people to solicit their products in Nevada are required to obtain a license pursuant to chapter 639 of Nevada Revised Statutes.

### **MA – Manufacturer**

Nevada licenses non-resident (out-of-state) manufacturers as wholesalers because the business activity they conduct in Nevada is wholesaling. Therefore, both instances of manufactures in this report are located in Nevada.

### **OUT - Outsourcing Facility (503B compounding facility)**

This license type is essentially a hybrid of pharmacy and manufacturing. 503B compounders must meet current good manufacturing practice (CGMP) requirements<sup>2</sup> and may wholesale the drug products they compound to pharmacies, medical facilities and practitioners. Many outsourcing facilities hire people to solicit the drug products they compound to Nevada practitioners and medical facilities, hence their compliance with Nevada’s MCC requirements.

### **MW - Medical Products Provider Wholesale License**

This license type was issued for years for wholesalers of devices. The MW license is no longer issued. Companies that wholesale devices are now issued a wholesale license. Most holders of the MW license have had their license converted to a WH license as the Board phases out the MW license. There is one instance of the MW license type on this report but that license has been closed.

### **MP – Medical Products Provider Retail License**

Another name for this license is an “MDEG” license. This license type is issued for retail dispensing of medical devices, equipment and gases to an end user. Some holders of an MP license file a MCC as seen on the tables that follow.
