18. Review of the results of the Nevada Pharmacists Workplace and Patient Safety Survey (FOR POSSIBLE ACTION)

Yenh Long, Deputy Secretary for the Nevada Board of Pharmacy, presented background on the Nevada Pharmacists Workplace and Patient Safety Survey and the results of the survey.

President Park opened the floor to public comment.

Ken Kunke from the Nevada Pharmacy Alliance submitted written public comments from the organization which highlighted actions taken by other states to address pharmacy working conditions and studies done by APHA and NASPA for the Board's review.

Kelsey Maxim, Director of Retail Pharmacy for the Community Health Alliance – Nevada, commented on the workplace conditions for Nevada pharmacists and recommends more pharmacist staffing to improve workplace safety conditions and decrease pharmacist burnout.

Liz MacMenamin from the Retail Association of Nevada commented that the Board considers an affordable path to assist with the workplace safety conditions and must consider the business model for Nevada retail pharmacies. She suggests adding more pharmaceutical technicians in the workplace to assist pharmacists.

David Vasenden, Owner of Sierra Family Pharmacies, commented that the pharmaceutical technician ratio should not be limited to a 3:1 ratio but should depend on the pharmacy's practice setting and what the pharmacist can handle.

Andrew Jackson, Pharmacist, and representative of an institutional pharmacy commented that the Board considers the institutional pharmacy perspective due to the differences in the workload and job duties compared to the retail pharmacy setting.

President Park closed public comment.

Jay Devoy appeared as counsel on behalf of Lincare, Inc.

Brett Kandt, General Counsel for the Nevada Board of Pharmacy, prosecuted the cases alleging Lincare locations in Sparks and Yerington operated for a period of time without an Administrator approved by the Board.

The proposed stipulated penalties for Ngan Tan, Certificate of Registration No. 23478, are the following: 1) pay a fine of \$1,000 for the violations; 2) pay \$500 to partially reimburse the Board for recoverable attorney's fees and costs incurred in investigating and prosecuting this matter.

F. Walgreens Pharmacy #12540

(23-408-PH-N)

William Stilling appeared as counsel on behalf of Walgreens Pharmacy #12540.

Gregory Zunino, Senior General Counsel for the Nevada State Board of Pharmacy, prosecuted the case against Walgreens #12540 alleging that the pharmacy operated for a period of time without a managing pharmacist and failed to notify the Board of a change to its managing pharmacist.

Mr. Zunino presented a proposed Stipulation and Orders for the Board's consideration.

The proposed stipulated penalties for Walgreens Pharmacy #12540 are the following: 1) pay a fine of \$2,000 for the violations; and 2) pay \$500 to partially reimburse the Board for recoverable attorney's fees and costs incurred in investigating and prosecuting this matter.

Mr. Stilling agreed with the Stipulation on behalf of Walgreens' #12540.

Ms. Miller testified on the service of the Notice of Intended Action and Accusation and the 21-Day Letter on Mr. Magana.

Mr. Vanderdonck requested that Exhibits 1 and 2 be entered into the record, documenting service of the Notice of Intended Action and Accusation and 21-Day Notice of Hearing on Mr. Magana.

President Park admitted Exhibits 1 and 2 into the record.

Ms. Beggs cross-examined Ms. Harris.

Mr. Zunino called Monica Segedy, Investigator for the Nevada State Board of Pharmacy, as a witness.

Ms. Segedy appeared and was sworn in by President Park prior to answering questions and offering testimony.
