Bridget Kelly appeared as counsel on behalf of Sam Zand.

Brett Kandt, General Counsel for the Nevada State Board of Pharmacy, prosecuted the case alleging that the respondent permitted unauthorized access of his credentials with the PMP database, and failed to check MyRx report regularly as required by Nevada law.

Mr. Kandt presented a proposed Stipulation and Order for Case No. 21-229-CS-A-S for the Board's consideration.

The proposed stipulated penalties for Sam Zand, Certificate of Registration No. CS22466, are the following:

Respondent as the holder of Certificate of Registration No. CS22466 is placed on probation for a period of one (1) year with public reprimand; Respondent fined \$5,000 for the violations; and assessed \$1,000 in attorney's fees and costs.

Gregory Zunino, Senior General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging that Dr. Zamzow wrote a prescription for buprenorphine, a Schedule III controlled substance, when she did not hold an active DEA registration.

Mr. Zunino presented a proposed Stipulation and Order for Case No. 22-004-CS-S for the Board's consideration.

The proposed stipulated penalties for Heather Nicole Zamzow, Certificate of Registration No. CS09628, are the following: 1) that Dr. Zamzow's certificate of registration to prescribe controlled substances be revoked, with an allowance to petition for reinstatement after 1 year or when Dr. Zamzow obtains a DEA registration number, whichever is later; 2) that Dr. Zamzow pay a \$5,000 fine for the violations; and; 3) that Dr. Zamzow pay \$500 to partially reimburse the Board for recoverable attorney fees and costs incurred in investigating and prosecuting this matter. The fine and attorney's fees and costs are to be paid by April 30, 2025.

Brett Kandt, General Counsel for the Nevada State Board of Pharmacy, prosecuted the case against the respondents alleging that Thomas Dermatology was dispensing prescriptions without a valid dispensing registration for all dispensing practitioners.

Mr. Kandt presented a proposed Stipulation and Order for Case No. 19-105-CS-A-S for the Board's consideration. Per the proposed stipulation, all causes of action against Lopez-Sanglay, Smith, Spoon, Benes and Crovetti, as set forth in Counts 1, 2, 3 and 5, Paragraphs 10, 11, 12 and 14 of the Accusation, are hereby DISMISSED pursuant to NRS 622A.320(4). Lopez-Sanglay, Smith, Spoon, Benes and Crovetti shall each accept this Stipulation and Order as a WARNING against dispensing prescriptions for controlled substances or dangerous drugs to patients without a valid dispensing practitioner registration.

The proposed stipulated penalties for Douglas Thomas, Certificate of Registration Nos. CS06503, PD00297, and PD27397, are the following:

Respondent Thomas' Certificate of Registration Nos. CS06503, PD00297, and PD27397 are suspended for a period of one year. The suspensions are stayed subject to the following conditions: 1) a public reprimand; 2) Respondent fined \$8,000 for the violations; and 3) Respondent assessed \$3,000 in attorney's fees and costs.

The proposed stipulated penalties for Vincent Nalbone, Certificate of Registration No. CS08907, are the following: Respondent as the holder of Certificate of Registration No. CS08907 is placed on probation for a period of one year with public reprimand; Respondent fined \$2,500 for the violations; assessed \$1,000 in attorney fees and costs; and Respondent's practice subject quarterly inspections, not to exceed \$500 per inspection.

Sanette Severance appeared and was sworn in by President Park prior to answering questions and offering testimony.

Gener Tejero disclosed that he has a business relationship with William Stilling but he can participate in this matter fairly and without bias.

Gregory Zunino, Senior General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging that Dr. Severance failed to communicate matters which would enhance therapy through drugs to patient concerning his prescription.

Brett Kandt, General Counsel for the Nevada State Board of Pharmacy, prosecuted the case against Dr. Feingold alleging unlawfully issued prescriptions; failed to put into practice all necessary policies and procedures to maintain the security of the drug inventory in the course of operating Advance Medical; failed to keep and maintain a complete, accurate and readily retrievable records accounting for all controlled substances and dangerous drugs; and failed to query the PMP database both prior to issuing and upon dispensing controlled substance prescriptions.

Mr. Kandt presented a proposed Stipulation and Order for Case No. 23-118-CS-S for the Board's consideration.

The proposed stipulated penalties for Robert Feingold, Certificate of Registration Nos. CS15741, CS18837, CS28864, PD15741 and PD27479, are the following: Certificate of Registration Nos. CS154741, CS18837, CS28864, PD15741, and PD27479 are revoked. The revocations are stayed, and Respondent is placed on probation for a period of three (3) years subject to the following conditions: 1) a public reprimand; 2) Respondent fined \$13,000 for the violations; and 3) assessed \$3,000 in attorney's fees and costs.

The proposed stipulated penalties for Prosthetic Center of Excellence, License No. MP00109, are the following: 1) pay a \$2,000 fine for the violations; and 2) pay \$500 to partially reimburse the Board for recoverable attorney fees and costs incurred investigating and prosecuting this matter.

Mr. Kandt presented a proposed Stipulation and Order for Case No. 23-266-CS-A-S for the Board's consideration.

The proposed stipulated penalties for Jason Dazley, Certificate of Registration No. CS25977, are the following: Respondent as the holder of Certificate of Registration No. CS25977 is placed on probation for a period of one year with public reprimand; Respondent fined \$2,500 for the violations; and assessed \$1,000 in attorney fees and costs.

Mr. Zunino questioned Ms. Miller and Ms. Phaynarikone on their positions at the Nevada Board of Pharmacy and what their responsibilities include.

Mr. Zunino questioned Ms. Miller on serving the Accusation upon Ms. McDonald.

Mr. Zunino questioned Ms. Phaynarikone on serving the Notice of Hearing upon Ms. McDonald.

Mr. Zunino commented that he called and emailed the respondent regarding this Accusation and Notice of Hearing with no response. He would like to proceed with a default hearing.

Mr. Zunino requested the Board find that Ms. McDonald was adequately and properly noticed of the hearing.

The proposed stipulated penalties for Cristy O'Connell, Certificate of Registration No. CS25857, are the following:

Respondent as the holder of Certificate of Registration No. CS25857 is placed on probation for a period of one year with public reprimand; Respondent fined \$2500 for the violations; assessed \$1000.00 in attorney's fees and costs; and Respondent's practice subject to quarterly inspections Respondent's expense, not to exceed \$500 per inspection.

Steven Camp, President and Owner, appeared and was sworn in by President Park prior to answering questions and offering testimony.

Brett Kandt, General Counsel for the Nevada State Board of Pharmacy, prosecuted the case against Archway Apothecary, charged with engaging in unprofessional conduct as detailed in the California State Board of Pharmacy's Order entered in Case No 7175..

Mr. Kandt presented a proposed Stipulation and Order for Case No. 23-441-PH-O for the Board's consideration.

The proposed stipulated penalties for Archway Apothecary, Pharmacy License No. PH04307, are the following: 1) Pharmacy License No. PH04307 will be suspended until November 30, 2025, concurrent with the California Board of Pharmacy action; the suspension is stayed, and Archway Apothecary is placed on probation subject to the following terms: 1) Respondent shall notify the Board of any change in status of their probation with the California State Board of Pharmacy in that case; and 2) Respondent assessed \$1,000 in attorney's fees and costs.

The form of notification is subject to approval by Board staff, and Respondent must submit the list to Board staff; 2) the Managing Pharmacist, Designated Person, and Sterile Compounding Personnel shall complete USP Implementation Training, CORE Compounding Training and Sterility Assurance Training courses through accredited vendor PCCA, and documentation of completion shall be provided to Board staff; 3) the Managing Pharmacist and Designated Person shall complete all CE modules comprised of all Sterile Compounding Training Schedule through Critical Point, and documentation of completion shall be provided to Board staff; 4) upon completion of above amendments, Respondent shall be subject to an inspection by Board staff prior to resuming sterile compounding; inspection shall count towards one of the quarterly inspections required in original Stipulation; 5) each pharmacist and pharmaceutical technician shall also complete the USP Implementation Training, CORE Compounding Training and Sterility Assurance Training courses through accredited vendor PCCA, and documentation of completion shall be provided to Board staff prior to engaging in sterile compounding; and 6) Respondent shall have two (2) additional inspections complete by the National Association of Boards of Pharmacy (NABP) during the probationary period, with results sent to Board staff.
