5. Disciplinary hearings pursuant to NRS 639.247. (**FOR POSSIBLE ACTION**)

N. Lincare, Inc

(24-324-MP-N)

Jay DeVoy was present.

Gregory Zunino, Senior General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging Lincare failed to properly service the respiratory equipment furnished to a patient at least every 24 months as required by the manufacturer's product manual.

The proposed stipulated penalties for Lincare, Inc. License No. MP00015 are the following: 1) Respondent fined \$1,000; and 2) Respondent assessed \$1,000 in attorney's fees and costs.

President Park was familiar with Sean Barclay from Roseman University but could participate in this matter fairly and without bias.

Sean Barclay and William Stilling were present.

Brett Kandt, General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging that Meta Pharmacy Services and Sean Barclay as owner/managing pharmacist, and/or pharmacy employees, filled and dispensed unlawful prescriptions for controlled substances and compounded semaglutide, employed one pharmaceutical

technician in training (PTT) on an expired registration and another PTT without obtaining a registration to work at Meta Pharmacy.

Mr. Kandt commented that a change of ownership application had been submitted on behalf of Meta Pharmacy. The parties then presented a proposed stipulation to resolve the matter.

Board discussion ensued.

The hearing was recessed so the parties could meet to discuss proposed amendments to the stipulated penalties. The hearing resumed, and the parties presented the following proposed stipulation for the Board's consideration:

Respondent's Barclay's Certificate of Registration No. 17303 is revoked, the revocation is stayed, and respondent is placed on probation for a period of ten (10) years subject to the following conditions: 1) a public reprimand; 2) pay a \$10,000 fine for the violations; 3) pay \$2,000 in attorney's fees and costs; 4) 12 additional continuing education on pharmacy law and ethics within six months of the Order date; 5) shall not be a managing pharmacist at Meta Pharmacy or any pharmacy licensed by the Board during the probation period; 6) shall divest himself of any ownership interest in Meta Pharmacy within 90 days of the Order and shall not hold any ownership in any pharmacy licensed by the Board during the probation period; and 7) shall not work as a pharmacist for Meta Pharmacy for a period of two years from the effective date of the Order. Respondent Meta fined \$10,000 for the violations; \$2,000 in attorney's fees and costs; and quarterly inspections for a period of one (1) year not to exceed \$500 at owner's expense.

It was also alleged that Respondent Badten knowingly filled and dispensed unlawful prescriptions for controlled substances.

Kandt presented proposed stipulations for each respondent.

The proposed stipulated penalties for Michelle Lyn Badten, Certificate of Registration No. 14966-B are the following: 1) Respondent's Certificate of Registration No. 14966-B is suspended for a period of one (1) year, the suspension is stayed, and Respondent is placed on probation for one (1) year subject to the following conditions: 1) public reprimand; 2) Respondent fined \$1,000; and 3) Respondent assessed \$1,000 in attorney's fees and costs.
