Brian Convery, Esq. was present on behalf of CVS Pharmacy #17244.

Kimberly Kersten was present.

Jade Jacobo recused herself from this matter due to her employment with CVS.

Brett Kandt, General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging that CVS Pharmacy #17244 is responsible for the acts of its employees who made an error in a prescription and failed to provide medication counseling to a patient..

Mr. Kandt presented the proposed stipulations for each respondent.

The proposed stipulated penalties for Kimberly Kersten, Certificate of Registration No. 20889, are the following: 1) Respondent fined \$1,500 for the violations; and 2) Respondent assessed \$500 in attorney's fees and costs. The fine and fee will be due and payable by September 1, 2025.

The proposed stipulated penalties for CVS Pharmacy #17244, Pharmacy License No. PH02188, are the following: 1) Respondent fined \$3,000 for the violations; and 2) Respondent assessed \$1,000 in attorney's fees and costs. The fine and fee will be due and payable by September 1, 2025.

Brett Kandt, General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging that respondent engaged in the business of selling, leasing, supply and/or distributing medical devices to hospitals and other licensed care facilities without a license to engage in business as a wholesaler.

Mr. Kandt presented the proposed stipulation for the respondent.

The proposed stipulated penalties for Hill-Rom Company Inc., License No. MP00038, are the following: 1) Respondent fined \$2,500 for the violations; and 2) Respondent assessed \$500 in attorney's fees and costs.

Mr. Kandt noted that the respondent paid a \$5,000 Citation and Fine due to unlicensed practice from the Board and since then has applied for a wholesaling license in Nevada.

Q. Pulmonary Solutions, LLC (22-357-MP-N)

Gregory Zunino, Senior General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging that Respondent engaged in business as a medical products provider

and failed to service and communicate with a patient who needed emergency oxygen equipment and supplies.

Mr. Zunino stated that Count Nine of the accusation will be dismissed and presented the proposed stipulation for the respondent.

The proposed stipulated penalties for Pulmonary Solutions, LLC, License No. MP02951, are the following: 1) Respondent acknowledges that License No. MP02951 was forfeited when it was not renewed; 2) Respondent fined \$8,000 for the violations; and 3) Respondent assessed \$1,000 in attorney's fees and costs.

Gregory Zunino, Senior General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging that Respondent issued or caused to be issued at least one hundred twenty (120) prescriptions for controlled substances while travelling out of country which is in violation of Nevada Law. In addition, respondent participated in deceitful transactions and billed Medicaid for services that respondent did not provide. Additionally, The Board took reciprocal action based on discipline that the Nevada State Board of Medical Examiners took for numerous findings of professional misconduct.

The proposed stipulated penalties for Matthew Okeke, Certificate of Registration No. CS10935, are the following: 1) Respondent's Certificate of Registration No. CS10935 is revoked, effective immediately, and Respondent shall not petition for reinstatement for a period of one (1) year; 2) Respondent fined \$10,000 for the violations, payable if Respondent petitions for reinstatement; and 3) Respondent assessed \$3,000 in attorney's fees and costs, payable if Respondent petitions for reinstatement.

Brett Kandt, General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging that Respondent compounded essential copies of commercially available drugs without a "statement of significant difference" for each prescription documenting a medical need specific to the patient for the compounded product.

Mr. Kandt requested to amend paragraph 2 of the accusation to reflect the date of "January 1, 2022" instead of "January 1, 2002".

Mr. Kandt called Kenneth Scheuber as a witness.

Kenneth Scheuber, Investigator for the Nevada Board of Pharmacy, was sworn in and subject to examination.

Mr. Kandt questioned Mr. Scheuber on the components of Exhibit A, and requested that it be admitted into the record.

The Board questioned Ms. Stefko and received testimony.

Both parties gave their closing remarks.

However, she was convicted of two felony offenses in July 2022.

Mr. Zunino requested that proof of service of the Notice of Hearing, the certified mail

tracking numbers of the Notice of Hearing, and the memorandum of fees and costs be admitted into the record as Exhibits 1-3.

President Park admitted Exhibits 1-3 into the record.
