Joshua Dickey appeared as counsel on behalf of Yuko Sweatt.

Brett Kandt, General Counsel for Nevada Board of Pharmacy, prosecuted the case alleging that Respondent Sweatt failed to secure dangerous drugs in a locked cabinet thereby allowing access to dangerous drugs by unlicensed personnel and administered drug products to a patient that were not acquired in compliance with Nevada Law.

Mr. Kandt presented a proposed Stipulation and Order for Case No. 22-214-CS-S for the Board's consideration.

The proposed stipulated penalties for Yuko Sweatt, Certificate of Registration No. CS28545, are the following: 1) public reprimand; 2) Respondent fined \$5,000; and 3) Respondent assessed \$1,000 in attorney fees and costs. The fine and attorney's fees and costs are due and payable by June 1, 2025.

MP00772 and MP00026 are the following: 1) Respondents licenses were forfeited as they were not renewed and Respondent would not be eligible to apply for a license or engage in business as a medical products provider or medical products wholesaler for a period of two (2) years after the effective date of this Stipulation; 2) public reprimand; 3) Respondent shall refund payments or deposits as described in sections 1a, 1b, 1c, 1d, and 1f of the Investigate Report in Case No. 24-334-MP-S by June 30, 2025; 4) Respondent fined \$5,000; and 5) Respondent assessed \$1,000 in attorney's fees and costs.

The proposed stipulated penalties for Walgreens Pharmacy #07032, License No. PH01747 are: 1) Respondent fined \$2,000 due and payable by May 1, 2025; and 2) Respondent assessed \$500 in attorney's fees and costs due and payable by May 1, 2025.

The proposed stipulated penalties for Jennifer Englehaupt, Certificate of Registration No. 15287 are: 1) Respondent fined \$500 due and payable by May 1, 2025; and 2) Respondent assessed \$500 in attorney's fees and costs due and payable by May 1, 2025.

The proposed stipulated penalties for Walgreens Pharmacy #03845 License No. PH01064 are: 1) Respondent fined \$1,000; and (2) Respondent assessed \$500 in attorney fees and costs.

Melissa Shake, Health Care Supervisor for Walgreens, was called to testify by Mr. Stilling.

President Park admitted Exhibits 1-6 into the record.

Mr. Stilling moved to dismiss all claims on the basis of hearsay.

President Park denied Mr. Stilling's motion to dismiss.

Mr. Stilling called Amanda Biggart Chief Operating Officer for Safe Chain Solutions, as a witness. Ms. Biggart was sworn and subject to examination.

Mr. Stilling called Dakota Flowers Compliance Manager for Safe Chain Solutions as a witness. Ms. Flowers was sworn and subject to examination..

The Board received evidence and heard testimony.

Gregory Zunino, Senior General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging that Ms. Calderon diverted controlled substances from her place of employment at CVS Pharmacy #8807.

Mr. Zunino requested that pages 2979-2984 of Board Book be entered into the record as Exhibit 1.

President Park admitted Exhibit 1 into the record.

The Board received evidence and heard testimony from Ms. Calderon.

Mr. Kandt requested that a prescriber activity report and an emailed statement that Dr. Siems provided to the DEA be entered into the record as Exhibit A and Exhibit B, respectively.

Dr. Siems had no objection.

President Park entered Exhibit A and Exhibit B into the record.
