Bridget Kelly (Counsel) was present on behalf of McGuff Compounding Pharmacy Services, Inc. and McGuff Company, Inc.

Brett Kandt, General Counsel for the Nevada Board of Pharmacy, prosecuted the case alleging the California State Board of Pharmacy entered an Order in approving a stipulated settlement for voluntary surrender of Respondent McGuff Compounding Pharmacy's California licenses for numerous violations of federal and California state law related to compounding drug products, and the Board took reciprocal action.

The charges against McGuff Company, Inc. were dismissed as they were not relevant to the issue of violating compounding laws and standards.

The proposed stipulated penalties for McGuff Compounding Pharmacy Services, Inc, License No. PH01563, are the following: 1) Respondent's License No. PH01563 is revoked; 2) Respondent fined \$5,000 for the violations; and 3) Respondent assessed \$1,000 in attorney's fees and costs.
